

Proof of Full Vaccination or Negative COVID-19 Test – Guests Frequently Asked Questions

1. What does fully vaccinated mean?

For the purpose of this process, “fully vaccinated” means the guest has received the recommended number of doses of COVID-19 vaccine, or combination of COVID-19 vaccines approved by Health Canada, and 14 or more days have passed since the guest received the last of the recommended number of doses.

2. What is acceptable proof of vaccination?

Guests must show proof of full vaccination in order to gain entry to Casinos Regina and Moose Jaw. For Saskatchewan residents, acceptable proof of full vaccination includes a COVID-19 Vaccination Certificate available from MySaskHealthRecord or the wallet card received at the time of COVID-19 vaccination. The wallet card must clearly indicate the guest’s first and last name, as well as their COVID-19 vaccination date(s) to demonstrate full vaccination.

3. What if I’m fully vaccinated but visiting the casino from out-of-province or out-of-country?

For the purposes of out-of-province or out-of-country guests, Casinos Regina and Moose Jaw will accept similar COVID-19 Vaccination Certificates or passports issued by other provincial, territorial or national governments.

4. What if I have one dose from a required two-dose vaccine, can I still enter Casinos Regina and Moose Jaw?

If you are not fully vaccinated you are unable to enter Casinos Regina and Moose Jaw without first providing proof of a negative COVID-19 test. The negative COVID-19 test must be valid within 72 hours from when the guest requests to gain access to the casino property.

5. If I have proof of a negative COVID-19 test, can I enter Casinos Regina and Moose Jaw?

Yes, guests can gain entry to Casinos Regina and Moose Jaw with proof of a negative COVID-19 test. The test must have been obtained from an approved Saskatchewan provider or from an out-of-province or out-of-country testing site with an accompanying proof of negative COVID-19 test certificate. The negative COVID-19 test must be valid within 72 hours from when the guest requests to gain access to the casino property.

6. Where do I obtain a COVID-19 test in Saskatchewan?

7. What if I took a COVID-19 home test? Can I still enter the casinos?

No, COVID-19 home tests are not accepted as proof of a negative COVID-19 test. The negative COVID-19 test must have been obtained from an approved Saskatchewan provider or from an out-of-province or out-of-country testing site with an accompanying proof of negative COVID-19 test certificate. The negative COVID-19 test must be valid within 72 hours from when the guest requests to gain access to the casino property.

8. What do I do if I don't want to disclose my full vaccination status or show proof of a negative COVID-19 test?

Guests who do not disclose their full vaccination status or show proof of a negative COVID-19 test will be denied entry.

9. What happens if I can't get a negative COVID-19 test prior to entering Casinos Regina and Moose Jaw?

Guests who do not disclose their full vaccination status or show proof of a negative COVID-19 test will be denied entry.

10. What if I have a pre-existing condition/compromised immune system and I'm unable to get vaccinated?

Guests with a pre-existing condition or a compromised immune system are required to present proof of a negative COVID-19 test in order to gain entry to Casinos Regina and Moose Jaw. The test must have been obtained from an approved Saskatchewan provider or from an out-of-province or out-of-country testing site with an accompanying proof of negative COVID-19 test certificate. The negative COVID-19 test must be valid within 72 hours from when the guest requests to gain access to the casino property.

11. Do I need to show current government-issued photo ID with my proof of full vaccination or negative COVID-19 test?

Yes, guests of Casinos Regina and Moose Jaw are required to show current government-issued photo ID featuring a unique identification/code along with their proof of full vaccination or negative COVID-19 test.
